EETT Competitive Grant Application Underway

Fifty-nine school districts and 32 direct-funded charter schools in CTAP 11 are eligible to apply for the federal Enhancing Education Through Technology Competitive grant program. This portion of EETT is regionally competitive, with a projected amount of \$4.2 million for successful districts in CTAP 11.
